In a court filing on Friday, presiding judge Deborah A. Tynan indicated she is taking a fresh look at a claim filed by plaintiff and alleged victim Virginia Giuffre against Epstein, his ex-girlfriend and fellow defendant Ghislaine Maxwell and two unnamed employees of Epstein's Florida residences. "On September 25, 2019, the parties were notified that their jurisdiction over the plaintiffs was defective in that the parties are not citizens of this Commonwealth. Accordingly, this court is required to dismiss the case," the filing in N.J. federal court said. The defendants are Epstein; his longtime friend and former girlfriend, Maxwell; two unnamed employees who are accused of working at Epstein's residences in Florida, including the Orchids of Asia cultivation site in Palm Beach, as well as the Caribbean island that housed their mansion. A Southern District of New York judge in July previously ruled that "Epstein is entitled to a ruling on his pending motions for summary judgment" against the accusers. Virginia Giuffre, who told NBC News in an exclusive interview that she was a victim of sex trafficking, filed the lawsuit in January. She is a former "sex slave
